CSOC is pleased to offer this streamlined application process for anyone who would like to present at our conferences. We offer 3 conferences for the Sheriff and Undersheriff of Colorado. We are always looking for presentations that are relevant to these executive level leaders. Our Winter Conference and Vendor Show takes place in January every year and is the largest vendor show for law enforcement in the state. We also provide a 3 day conferences for Sheriffs and Undersheriffs in April and in August.

The Winter Conference and Vendor Show is always in Loveland, Colorado and we invite Chiefs of Police, State Law Enforcement Leaders, and command level personnel to attend. The Spring and Fall conferences are held all over the state. Each sheriff is offered the opportunity to host a Spring/Fall conference in their county. We typically know where these conferences will be held 1 year prior.

At our conferences we have the Undersheriff attend the first half and the sheriff attend the second half with a common day to both in the middle of the week/3 days.

Meaning that the entire conference may be based on a specific topic, current event, or issue facing the counties and/or law enforcement in general.
